- » We observe a formation of bearish candlestick pattern as per daily timeframe chart.
- » Volume has started to rise along with downside in the stock price.
- » The intraday/daily RSI is showing negative indication.
- » The overall bearish chart pattern of the stock price indicates short trading opportunity. One may look to buy Put Options as per the levels mentioned above.
